Description

This project is being undertaken as part of the cross-institutional Working Group project, through the Student Voice Australasia (SVA) and hosted by the University of Southern Queensland.

Student Voice Australasia is conducting a nationwide survey to explore how higher education institutions in Australia reward and recognise the time, effort, and contribution students make to enhance the quality of education and the student experience.

The purpose of this project is to better understand how student voice is recognised across different institutions and inform a nationwide conversation about appropriate forms of recognition for student contributions across the sector.

Open questions: Eg.: *Has there been any discussion or projects to address reward and recognition of student voice? Have you come across any barriers to implementing them?*

Your participation in this project is entirely voluntary. If you do not wish to take part, you are not obliged to. If you decide to take part and later change your mind, you are free to withdraw from the project at any stage. You may also request that any data collected about you be withdrawn and confidentially destroyed.
